SPORTS GRANT FOR ORGANISATIONS

To promote and foster healthy and active tribal members, this Sports Grant is made available to Organisations whose membership consists of a minimum of 50% of tribal members. This Grant is available to Organisations that have a strong affiliation to Waikato-Tainui and its Marae and who align with Whakatupuranga 2050 and or Kiingitanga and the visions of Maximising our collective strengths and achieving our aspirations.

Other information is as follows.

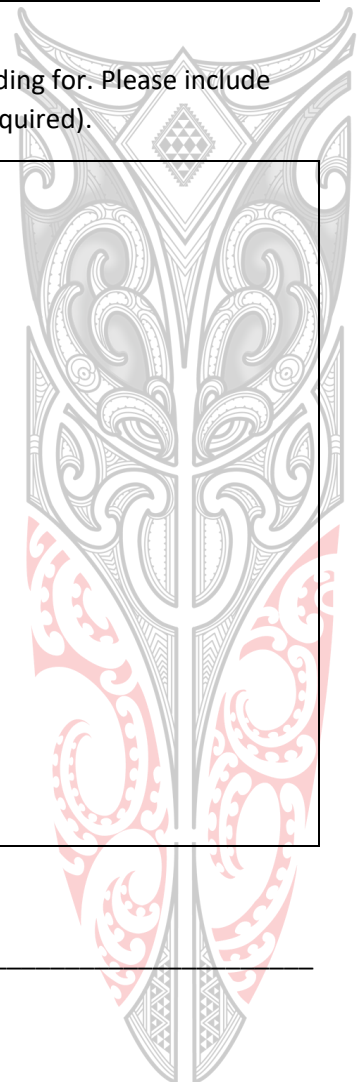
- Applications are considered by the Sports Grant Advisory monthly, for funds that are to be used in the future. No grants will be given retrospectively.
- Organisations may receive one Grant per financial year (1 April – 31 March).
- Expenses that will not be covered under the Sports Grant include personal equipment or training items for individuals and costs associated with after match functions or social gatherings towards your Tournament.
- Applications to attend tournaments competing for cash prizes will not be supported.
- Applicants must provide Confirmation of entry into the Tournament, in the form of a Formal letter from the Organisations Governing Body.
- We may request receipts at the completion of your Tournament, to ensure that the funds have been allocated correctly, as outlined in this application form.
- Funds must be used towards the Tournament you have stipulated in this application and cannot be held for any other purpose other than what has been stipulated to us.
- Applications are tabled at a monthly Board meeting for approval. All applications received within the first week of the month will be tabled with the Board at the end of that month. All applications received outside of the first week of the month will be tabled with the Board in the next month.
- Decisions about application outcomes are final and no correspondence will be entered in to.
- Successful applicants may be asked to participate in Waikato-Tainui tribal events or promotional purposes as role models for healthy and active living. Participation in these types of events is noted as completion of your Koha Statement and may impact on your eligibility for future Grants.
- Sole discretion as to whether we accept or decline an application rest with us.
- Organisations can only apply for Grants for all teams associated with their Organisation and cannot apply for the benefit of one single Team.
